This RFP concerns the awarding of a contract (hereinafter referred to as the “Contract”) outside of the scope of Act No. 137/2006 Coll., on public procurement, as amended (hereinafter referred to as the “Act”), it is not a public competition pursuant to Sec. 1772 and following of Act No. 89/2012 Coll., the Civil Code (hereinafter referred to as the “Civil Code”).

2. Subject of RFP

- 2.1. **The subject of this RFP is delivery of professional hand-operated laser unit for bird strike prevention at an airport (class MAX – 3B) including training on site and providing service works and spare parts delivery.**
- 2.2. The RFP participant by sending offer agrees to provide complimentary to LP one piece of professional hand-operated laser unit for bird strike prevention at an airport for 6 weeks because of testing purposes. This unit can be lower laser intensity – 2M than above required one, because of regulation and rules for using laser unit of stronger classes.

3. Requirements for RFP quotation

- 3.1 Participants shall specify in their RFP quotation the company identification data (name, address, ID), contact person.
- 3.2 RFP quotation shall include detailed parameters of offered professional hand-operated laser unit for bird strike prevention at an airport.
- 3.3 The RFP quotation should be made out in Czech or English language.
