Invitation to Participate in a Preliminary Market Consultation

Letiště Praha, a. s. (hereinafter referred to as “**Contracting Authority**”) is announcing, pursuant to Section 33 of Act No. 134/2016 Coll., on public procurement, as amended (hereinafter referred to as “**PPA**”), a Preliminary Market Consultation related to the forthcoming public contract whose subject matter will be:

Design development and subsequent expert advisory related to prospective construction of new aircraft hangar at Prague Airport (LKPR) to hold and provide aircraft maintenance services, entitled in general as “LKPR Hangar – Preliminary Design Study”

(hereinafter referred to as “**Study**”).

**The Contracting Authority hereby invites you to participate
in the Preliminary Market Consultation.**

2. THE PURPOSE OF PRELIMINARY MARKET CONSULTATION

The purpose of this Preliminary Market Consultation is

- (i) **to recognize the interest of consultants to co-operate in above-mentioned project during the pre-design and preliminary design phase related to planning and following development of a new aircraft hangar at Prague Airport and**
- (ii) **to obtain and confirm the initial information related to scope of work of the Study as well as to validate the best practice approach in regards to prospective public contract associated with the Study.**

Over the course of the Preliminary Market Consultation, care shall be taken to protect trade secrets and personal data and other confidential information provided by the participants in the Preliminary Market Consultation. The Preliminary Market Consultation shall be conducted in such a way as not to distort competition and not to violate the basic principles of public procurement. The information resulting from the Preliminary Market Consultation shall be included in the tender documentation of the public contract in question in accordance with the requirements of the PPA and to the extent stipulated by law. Participation of economic operators in the Preliminary Market Consultation shall not in any way affect their possibility to participate in the subsequent procurement procedure for this public contract, provided that they meet the conditions for participating in this procurement procedure.

3. SUBJECT MATTER OF THE PRELIMINARY MARKET CONSULTATION

Prague Airport is aiming to re-establish previously suspended (2006) design development intended originally to provide the design of new hangar for aircraft service purposes located within LKPR security restricted area. There was an original design submission (including valid zoning permit dated 2006) which needs to be re-evaluated independently and, as anticipated, re-designed in order to fulfil with the contemporary market requirements. Subsequently, the Contracting Authority intends to invite a consultant to provide Prague Airport with the pre-design advisory as well as preliminary design development/Study related to the new hangar.

As a part of the contract, an advisory related to further development of service areas including hangars for General Aviation will be provided.

The initial information of the subject matter of the Preliminary Market Consultation and the forthcoming public contract are provided in Annex No. 1 to this Invitation.

4. COURSE OF THE PRELIMINARY MARKET CONSULTATION

The opportunity to participate in this Preliminary Market Consultation is open. Particularly, all potential contractors may participate.

This Preliminary Market Consultation shall be conducted in written form, eventually in the form of verbal negotiations to clarify information. If the Preliminary Market Consultation takes the form of verbal negotiations, the participants in the Preliminary Market Consultation shall be notified of the place and time of the Preliminary Market Consultation.

5. DEADLINE FOR DELIVERY OF THE STATEMENT OF THE PARTICIPANT IN THE PRELIMINARY MARKET CONSULTATION

Statements of the participants in the Preliminary Market Consultation should be delivered to the Contracting Authority no later than January 17th, 2022.

Any potential contractors interested in participating in this Preliminary Market Consultation but temporarily unable to submit their statement within the specified time frame may even submit their statements thru above-mentioned e-mail after January 17th, 2022 but definitively no later than January 31st, 2022. The Contracting Authority should review such statements and evaluate accordingly to the phase of consultations whether the potential contractor will be allowed to participate in the consultation.
